New Hope Academy of Tennessee (NHAT) is a private, Christian school that assists parents who homeschool their children. As such, NHAT espouses foundational Christian beliefs, and by enrolling with NHAT, I affirm it is my intention for my student(s) to receive a Christian-based education, and that my signature below affirms my belief in and adherence to the school's policies. (Throughout this document the term parent will refer to legal guardian if applicable.) We offer optional, online classes in addition to our primary record-keeping, consultation, and standardized testing services. Listed below are some of NHAT's guidelines and requirements to which all families are required to adhere. Please read them carefully before enrolling.

- 1) Parents are responsible for the education of their child(ren). As such, I understand and agree to the following:
 - a) My child(ren) will receive a Christian education while enrolled with NHAT, and my beliefs align with NHAT's Statement of Faith.
 - b) I agree that NHAT will recognize and refer to my child(ren) based on his or her birth gender.
 - c) I will enroll each year by the time school starts in my school district or August 1st. If I do not plan to re-enroll for the next school year, I will notify NHAT.
 - d) I will provide accurate student and contact information to NHAT and update within two weeks of changes that occur.
 - e) I will maintain grade and attendance records and submit them to NHAT twice yearly by January 15 and June 15.
 - f) I will pay all fees promptly when due. I have reviewed and accept the fee table and refund policy as posted on www.NewHopeAcademyTN.com and understand that fees may be subject to change.
 - g) I will complete the Curriculum Plan (on Enrollment Form) each year for each student.
 - i) I understand that NHAT staff is available to answer questions and make recommendations on curriculum.
 - ii) I understand that NHAT offers online classes with fee for 3rd through 12th grade for interested families.
- 2) NHAT has strict procedures for processing enrollment of students with legal, substance, academic, or other issues. "Yes" answers to questions on the enrollment form as well as information from previous schools will be evaluated carefully to ensure the best chance of academic success for all involved.
 - a) I understand that while truancy, arrest, probation, suspension, expulsion, and other issues are not necessarily reasons for non-acceptance, falsifying the information on the enrollment form or other communications with NHAT is, and will result in forfeiture of all fees paid and student being dropped from enrollment.
 - b) I understand that NHAT has a Tailored Program with fee for students who require additional oversight and that a zoom conference before enrollment is required for students in the Tailored Program.
- 3) NHAT requires standardized testing during the 4th, 7th, 9th, 10th, 11th, and 12th grades.
 - a) I understand that my student can take the Stanford Test with fee through NHAT in the spring.
 - b) If my student prefers to take the ACT or SAT, I will sign up directly with that organization and have scores transmitted to NHAT. (NHAT's school code is 430-141 and will be added to the ACT or SAT as the school's code.)
- 4) Tennessee has specific state standards and requirements for graduation. NHAT assists parents by providing a graduation checklist for high school students to provide them a clear graduation pathway.
 - a) I understand that I am responsible for reviewing the checklist twice yearly to make sure my student stays on track for graduation.
 - b) I understand that my student must satisfactorily complete the minimum graduation requirements to earn and be awarded a High School Diploma from NHAT.
 - c) I understand that cheating will result in expulsion from NHAT.
 - d) If I am not a Tennessee state resident, I understand that I must comply with the home schooling laws in my state and can request NHAT staff assistance.

My signature indicates I have read and agree to these policies and will follow them. If I have any questions or concerns, I will address them with NHAT staff before enrollment.
